December 19, 1977 – Concerns are raised about the possibility of methane gas entering the clubhouse of the Gateway Community Club as the site was a former North Kildonan sanitary landfill site

December 20, 1977 – Appointed to the Henderson Regional Library Board

January 3, 1978 – The East Kildonan-Elmwood YMCA receives a further per capita grant of \$500

January 9, 1978 – Amounts in land dedication funds

East Kildonan - \$118,000

Transcona - \$17,000

January 16, 1978 – Expropriation proceedings are begun against the ROCO (Radio Oil Company Limited) property in the block bounded by Golspie, Raleigh, Munroe and Winterton

February 6, 1978 – The official opening of the new North Kildonan Community Club's building is to be held February 23, 1978

Rising water levels on Bunn's Creek causes the excess flow to be diverted into the sewer system as a temporary measure

February 13, 1978 – A storm sewer is being built in the Larchdale Crescent area to drain water directly into the Red River to solve the persistent flooding problems during periods of heavy rain and melting

The East Kildonan-Transcona Parks and Recreation Department appoints as recreational supervisors, Denis Guyot, Jim Sesack, Dianne Bannash, Brian Freeman and Jack Bysyck

February 20, 1978 – A home occupation license is given for an upholstery business for 291 Sydney Avenue

Stop signs are to be installed on Louelda at Prince Rupert

February 21, 1978 – The Community Committee is advised that city council plans to dissolve all autonomous library boards as of June 1, 1978 and to unify them all under one city library board as of January 1, 1979

It is proposed to reopen Panet Road at the C.P.R. Crossing for vehicular traffic

The River East School Division asks for the removal of the C.P.R. Overpass at Springfield Road and Henderson Highway and for traffic lights at Henderson and Springfield

The East Kildonan-Transcona Manitoba Winter Games Committee is given a grant of \$700

March 13, 1978 – Appointed as Resident Advisors to the East Kildonan-Transcona Subcommittee on Parks and Recreation are, Mr. David Bain, Mrs. Jo Lopuck, Mr. Chuck Walker and Mr. Ray Brunka

Permission is given to install a plaque at the intersection of Edison and Henderson Highway to commemorate the 50<sup>th</sup> Anniversary of the arrival of the Mennonites in North Kildonan

March 20, 1978 - A stop sign is to be installed on Sun Valley at DeVries

The Shops and Recreation section of the East Kildonan-Transcona Parks and Recreation Department are to move into 565 Watt Street next to the Parks Office at 545 Watt Street

The Community Committee is informed that it has been alleged that certain zoning inspectors are reluctant to carry out their duties at 194 Roch Street because of possible physical reprisals from an alleged auto repair and towing service at this address

April 3, 1978 – Permission is given to the Post Office to build a Letter Carrier Depot on Kimberly at London

Permission is granted to build a shopping centre at the southeast corner of Henderson Highway and McIvor

April 10, 1978 – Grants received from the provincial lotteries fund

April 24, 1978 – A grant of \$350 is given to the North-East Resource Council for a youth conference on May 4-5, 1978

May 8, 1978 – A beer garden is approved for the Valley Gardens Community Centre for June 3-4, 1978

It is decided that the major football field at Anderson Park will be used for soccer from the spring to the end of June. It will then be temporally fenced and kept out of service until September when it will be used for football

May 15, 1978 – An addition is approved for the Mennonite Brethren Bible College at 77 Henderson Highway

May 23, 1978 – The East Kildonan Country Fair receives a grant of \$1,000

May 29, 1978 – The Bowman Industrial Park Entrance on Bowman is to be closed to trucks from Bowman and Trueman Street once Raleigh is asphalted from Washington to Chalmers. The entrance is to be restricted to cars only as trucks will use a new entrance off Raleigh

June 5, 1978 – A beer garden license is approved for the Bronx Park Community Centre from June 23-25, 1978

June 12, 1978 – The Gateway Gun Club is given the property rent free for a period of 7 years with the gun club then agreeing to make repairs to the building at a cost of \$3,950

June 19, 1978 – Per Capita Grants given out to

St Alphonsus Catholic Women's League a grant of \$250 towards a Paddle Wheel Trip for seniors

North East Winnipeg Youth Company a grant of \$900

David W. Judge of 342 Stuart Avenue is appointed to fill the vacancy on the Henderson Regional Library Board until December 31, 1978 after the resignation of Mrs. L. Adkins of 130 Helmsdale Avenue

Peace Lutheran Church is given permission to build a church building and a parking lot with 43 spaces on the south side of Gilmore Avenue just west of Rothesay and north of Stuart

July 24, 1978 – The Manager of Streets and Traffic rejects the proposal to install traffic control signals at Henderson Highway and McIvor

There are complaints from residents disturbed from noise emanating late at night from the Afro-Caribbean Association of Manitoba Hall at 259 Watt Street. The Association is asked to apply for a dance hall license

August 8, 1978 – A home occupation license is granted to Florance Krilyk at 464 Robinhood Crescent for a ceramic studio

August 14, 1978 – A youth centre is suggested for the East End Barons Community Centre on Larsen which has now closed as a community centre due to the lack of people willing to run the centre

August 21, 1978 – A 3 storey 57 suite apartment block is approved for the north side of Kimberly east of Gateway

A \$200 per capita grant is given to the Grey Street Senior Citizens Club for an outing to the Morden Festival.

The Community Committee is told that the East Kildonan Country Fair operated by the Gateway Community Centre took in \$10,359 and after expenses they expected to make a \$4,000 profit

August 28, 1978 – A Citizenship award is presented to Mr. Gerry Homenick for his volunteer involvement in programs for the handicapped

Fifty residents express their concern about their flooded basements which occurred on July 27, 1978 after a rainstorm where 2.8 inches of rain fell during a 27 minute period.

The carriage house at Ross House at 1940 Henderson Highway is to be demolished due to its unstable and dangerous condition

September 5, 1978 – A proposal is brought forward to build a regional shopping centre (Kildonan Place)

Radio Oil Limited is convicted under the City's Untidy and Dangerous Premises By-Law 762/74 but Husky Oil Limited of Calgary is to pay the fine as it recently purchased the company

September 11, 1978 – With the ceasing of operations of the East End Barons Community Centre on Larsen the other community centres in the area take over the catchment area of the closed centre.

Bronx Park takes over the area on the south side of Munroe Avenue from Henderson Highway to Brazier and the area on the west side of Henderson Highway south of Munroe to Elmwood Park.

Kelvin Community Centre takes over the south side of Munroe from Brazier to Roch and the area south from Winterton to Larsen from Henderson Highway to Roch

Chalmers Community Centre takes over the south side of Munroe to Larsen from Roch to the Railway Tracks (Pioneers' Greenway)

There are complaints that cars are using the lane between Dunrobin and Centennial Park as a drag strip, cars are parking in the lane blocking traffic and teenagers are setting fires in Centennial Park

The former East End Barons Community Centre on Larsen is to be turned into a cultural and activity. A total of \$4,605 is to be taken from reserve funds for equipment

September 18, 1978 – The decision to demolish the carriage house at Ross House at 1940 Henderson Highway is reversed as the building is to be repaired

September 25, 1978 – Bonner Avenue is to be oiled from Henderson Highway to Raleigh at a cost of \$20,000

February 14, 1979 – The East Kildonan Library Estimates for 1979 total \$254,070

February 26, 1979 – The Community Committee recommends that the North Kildonan Centennial Park on McIvor be renamed North Kildonan Seventy Park a name originally proposed by the former Municipality of North Kildonan. It also suggests that a plaque be erected at the site listing the name of the mayor, municipal councillors and members of the North Kildonan Centennial Committee in 1970

Land along Edkar Crescent is to be sold to the McIvor Avenue Mennonite Church

The new east-west street running north of the Taxation Centre is to be named Reenders Drive

March 12, 1979 – A senior citizens apartment block with an expected 210 residents for the northeast corner of Kingsford Avenue and Henderson Highway

March 19, 1979 – Problems arise at the Gateway Community Centre when raw sewage filters into the fresh water system

March 26, 1979 – The River East Bantam Royals receive a grant of \$900

Miss Margaret Kennedy asks that the four Matheson grinding stones be reunited at the park at Edison and Henderson Highway. They were used in the flour grinding mill built on McLeod Creek in the late 1820's by Alexander Matheson

April 23, 1979 – S.P.I.K.E. Incorporated receives a grant of \$7,000 and the official opening at 1940 Henderson Highway is May 3, 1979

May 7, 1979 – A home occupation permit is given to Mr. B. Friedriches of 463 Emerson for a general contractor's office

A home occupation permit is given to Mr. G. L. Beckta of 55 Kirkwall Crescent as a plumbing and heating contractor's office

The name Stonchman Crescent is approved as a street name for the proposed subdivision located west of Pennefather and north of McIvor

A beer garden is approved for the Valley Gardens Community Centre from June 2-3, 1979

July 3, 1979 – Crosstown Credit Union is to move from its present site at 1110 Henderson to a new site at the southwest corner of Hawthorne and Henderson Highway

A gas bar is approved for 1795 Henderson Highway (McIvor Mall)

July 5, 1979 – Miss Margaret Kennedy complains that the Coulter Road street sign has been removed from its location on Molson. It was an east-west street beside the landmark home of J.H. Coulter a prominent market gardener and community leader. Coulter Road also ran on the east side of the Perimeter Highway paralleling it for a mile. She also asks that the name Haarsma be added to the list of future street names. John Haarsma came to Elmwood in the early 1890's market garden farming land in the vicinity of De Salaberry and later in North Kildonan and East St. Paul. She all tells the Community Committee that Mr. George De Graff on Coulter Road would like to donate his windmill to the city on the condition that it remain in the area

July 16, 1979 – A home occupation permit is given to Mr. C. Gross of 216-25 Valhalla Drive for a mini-computer distribution office

The Henderson log cabin donated by Mr. J. Seitz at 2112 Henderson Highway is not to be moved to the park behind Ross House at 1940 Henderson Highway because the directors of S.P.I.K.E think the site will become a tourist attraction.

July 31, 1979 – The East Kildonan Horticultural Society receives a grant of \$350

Four and three stop signs are to be placed at Rothesay and Devon and at Rothesay and Sharron Bay

August 7, 1979 – Home occupation permits approved

August 15, 1979 – The general plans for the Kildonan Place Shopping Centre are approved; it expected the shopping centre will employ 600 full time jobs, 300 part time jobs and create 400 construction jobs

August 20, 1979 – A home occupation permit is approved for Mrs. Verna Riddell of 303 Linden Avenue an upholstering shop

September 4, 1979 – Gateway Gun Club and Rifle Association at 900 Gateway receives a grant of \$560 to cover its taxes

September 18, 1979 – A home occupation permit is approved for Mr. R. Bucholz of 164 Tu-Pelo for a contractor's office for painting and decorating

Plans are introduced by the Knights of Columbus to establish a senior citizens day centre at the site of the old Concordia Hospital on De Salaberry

The entrance to the North Kildonan Community Centre on Kingsway is to be widened

September 25, 1979 – The Community Committee recommends traffic lights for Roch and Johnson

October 2, 1979 – A home occupation permit is approved for Mr. Roy E. Johnston of 1392 Kildonan Drive for a tree removal and wood suppliers office.

A home occupation permit is approved for Mr. T. Advincula of 519 Riverton for a general contractor's office

A home occupation permit is approved for Mr. R. M. Jupp of 75 Killington Bay for a hair dressing shop

The Go Kart Track at 1133 Molson is to now have a pinball and pool hall operation on site

The Community Committee is told that Mr. Martin Bergen owner of 210 Oakland Avenue is proceeding with building a restaurant at the top of 210 Oakland even though his application to build the restaurant was turned down

October 15, 1979 – A home occupation permit is given to Mr. P. Wildemann of 573 Cedar Crest Drive for a Music Man office

A home occupation is permit is given to Mr. L. Pelletier of 47 Pennefather for a building contractor's office

A credit union building is to be built at 558 Keenleyside Street

There are many complaints about the 3-way stop at Sharron Bay at Rothesay complaining it is not necessary

October 23, 1979 – It is proposed to connect Gilmore Avenue with Sun Valley Drive. An I.G.A grocery store is opening at Sun Valley and Gateway and the owners along with many residents and Winnipeg Transit are in favour of the connection. The connection was proposed in the 1980 Capital Budget but it was removed.

Mr. E.R. Osborne of 399 Linden Avenue receives a \$200 grant for the repair and recycling of donated toys for the underprivileged

The Grey Street Senior Citizens Club receives a grant of \$350 to assist in a catered Christmas dinner for the group

The Elmwood-Kildonan YMCA receive a grant of \$1,000 with a further grant of \$6,000 to be considered later in the year

The Bronx Park Senior Citizens group receive a grant of \$500 for a Christmas dinner for 50 people

Kildonan Horizons Inc. receives a grant of \$400 to reimburse private car owners, handi transit and taxis to transport senior citizens

St Gerard's Ladies Group receive a grant of \$400 to assist in holding a Christmas party for seniors

November 6, 1979 – A home occupation permit is given to Mr. J. Murphy of 320 Glenwood Crescent for a stage lighting office

A home occupation permit is given to Mr. E. Yusefawich of 524 Larsen for an insulation contractor's office

A second hand store license is approved for 440 ½ Watt Street

November 20, 1979 – A home occupation permit is given to Mr. Z. Jablonwski of 134 Evenlea Walk for a manufacturer's representative office

November 27, 1979 – Many complain about the patrons using Kaptain Kidd Arcade at 311 Henderson Highway at Martin and at the Amusement Parlour at 1415 Henderson Highway (The Board Walk). Residents complain about vandalism, rowdy behaviour, fights and intimidating the staff and patrons of other nearby businesses. Both businesses are owned by former City Councillor Norm P. Stapon of 483 Keenleyside Street. Mr. Stapon tells the Community Committee that he intends to cease operations at 311 Henderson Highway at the end of December 1979 but he has a long term lease at 1415 Henderson Highway. Councillor Harold Piercy tells Mr. Stapon that he will approach Landmark Leaseholds Limited to assist him in terminating his lease at 1415 Henderson Highway.
